Plans & building:

- Next day after excavation security fencing will go up. Temporary fencing first Dennis
 has contacted the company, 31 panels for 12 weeks \$650, anything over 12 weeks fees
 transfer to a daily rate.
- Raised beds and paths will go in after frame, cyclone fencing, boardwalk, shed completed.
- Strategic way for drainage and to ease soggy ground is to use road base then reassess as required.
